To the applicant:

- 1.According to NCTU Registration, students may apply for temporarily suspension with each semester as one unit. Undergraduate students must obtain the approval of their parents or guardians. The accumulated limit for temporary suspension is two academic years. Graduate students finished with their required credits must finish application before the end of the semester. Other students who apply for temporary suspension in the middle of the semester must complete the application before finals examination begins.
- 2. Those who complete the procedures for suspension before the Enrollment Day do not have to pay tuitions. Those who complete the procedures for suspension after the Enrollment Day (including) must pay tuitions.
- 3.Re-entry should be processed actively without any notice from Registrar. Registration process is considered complete when all required fees have been paid. If the student have not paid over the deadline, shall be considered un-registered, and shall be ordered to withdraw.
